Privacy Policy

MBBS recruitment values and respects the privacy of the people we deal with. MBBS recruitment is committed to protecting your privacy and complying with the Privacy Act 1988 (Cth) (Privacy Act) and other applicable privacy laws and regulations.

This Privacy Policy (Policy) describes how we collect, hold, use and disclose your personal information, and how we maintain the quality and security of your personal information.

What is personal information?

“Personal information” means any information or opinion, whether true or not, and whether recorded in a material form or not, about an identified individual or an individual who is reasonably identifiable. In general terms, this includes information or an opinion that personally identifies you either directly (e.g. your name) or indirectly.

What personal information do we collect?

The personal information we collect about you depends on the nature of your dealings with us or what you choose to share with us.

The personal information we collect about you may include:

- name.
- mailing or street address. date of birth.
- email address.
- phone number
- qualifications
- medical information
- family situation

MBBS recruitment may need to collect sensitive information about you. This might include any information about you and your family regarding health, professions, school status, membership of professional body, criminal record, or other information required to satisfy employers (as to your suitability for an offer of employment), immigration and regulation bodies within Australia.

If we collect your sensitive information, we will do so only with your consent and we take appropriate measures to protect the security of this information. The information is collected is solely used to make sure that you and your family are placed in a location that fits all your families needs , with an employer who is a good fit for your skills and expertise.



You do not have to provide us with your personal information. Where possible, we will give you the option to interact with us anonymously or by using a pseudonym. However, if you choose to deal with us in this way or choose not to provide us with your personal information, we may not be able to provide you with our services or otherwise interact with you.

How do we collect your personal information?

- We collect your personal information directly from you when you: interact with us over the phone;
- interact with us in person;
- interact with us online;
- participate in surveys or questionnaires;
- attend a MBBS recruitment event;
- subscribe to a mailing list; apply for a position with us as an employee,
- contractor or volunteer;
- through contacting references

Collecting personal information from third parties

We may also collect your personal information from third parties or through publicly available sources, for example from Medical registration boards, google searches, LinkedIn. We collect your personal information from these third parties so MBBS Recruitment can provide:

- An accurate picture of your suitability for employment to an employer and;
- verify your qualifications;
- check for any adverse reports of a personal or clinical nature that would affect your suitability for a particular position.

Disclosure of personal information to third parties

We may disclose your personal information to third parties in accordance with this Policy in circumstances where you would reasonably expect us to disclose your information. For example, we may disclose your personal information to:

Other recruitment consultants, Specialist Medical Colleges, administration bodies such as AHPRA, referral partners and clients; our professional services advisors: immigration agents and regulations consultants

Transfer of personal information overseas

Some of the third-party service providers we disclose personal information to may be based in or have servers located outside of Australia.

Where we disclose your personal information to third parties overseas, we will take reasonable steps to ensure that data security and appropriate privacy practices are maintained. We will only disclose to overseas third parties if:

you have given us your consent to disclose personal information to that third party; or
we reasonably believe that:

- the overseas recipient is subject to a law or binding scheme that is, overall, substantially similar to the APPs;
- the law or binding scheme can be enforced; or
- the disclosure is required or authorised by an Australian law or court / tribunal order.


How do we protect your personal information?

MBBS recruitment will take reasonable steps to ensure that the personal information that we hold about you is kept confidential and secure, including by:


having a robust physical security of our premises and databases / records;


taking measures to restrict access to only personnel who need that personal information to effectively provide services to you;

having technological measures in place (for example, anti-virus software, fire walls);

Online activity

In most cases, this means that we will only retain your personal information for the duration of your relationship with us unless we are required to retain your personal information to comply with applicable laws, for example record-keeping obligations.
